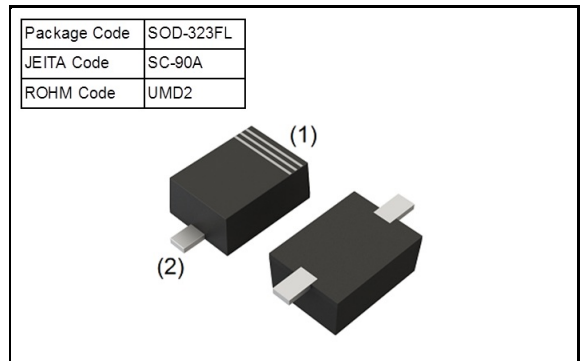

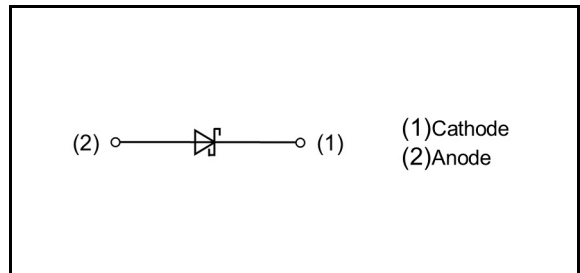
#### 使用上の注意

#### ● 外形図



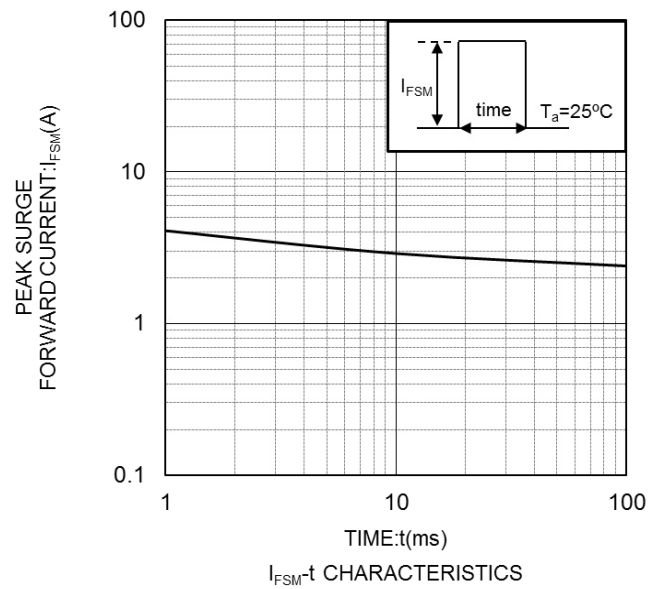
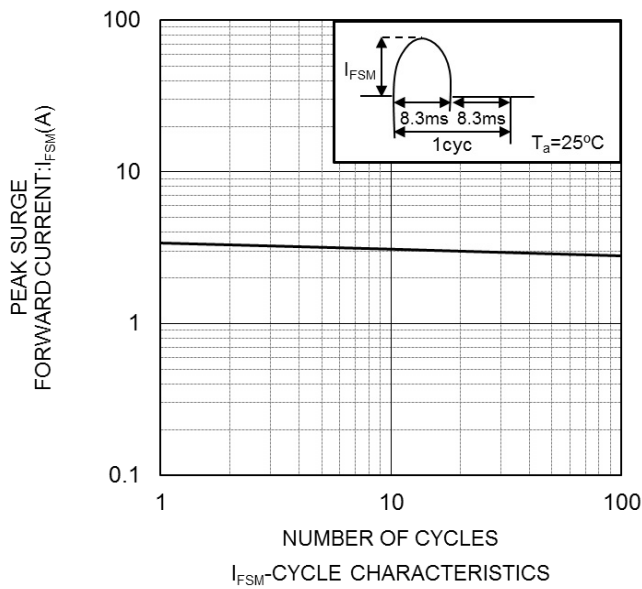
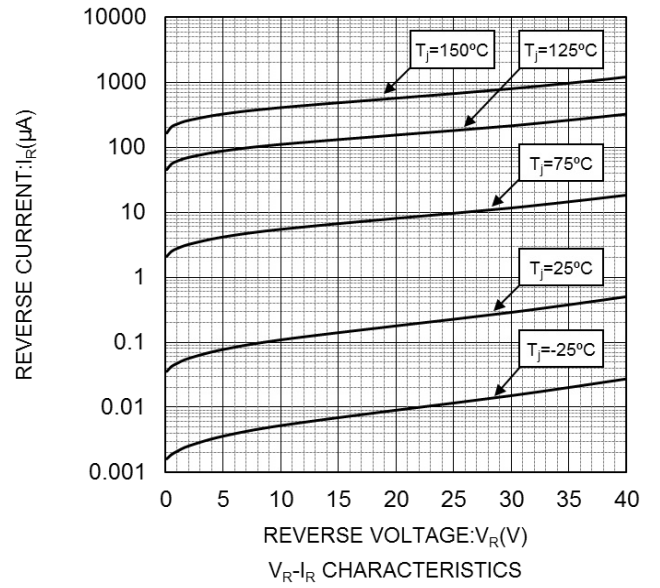
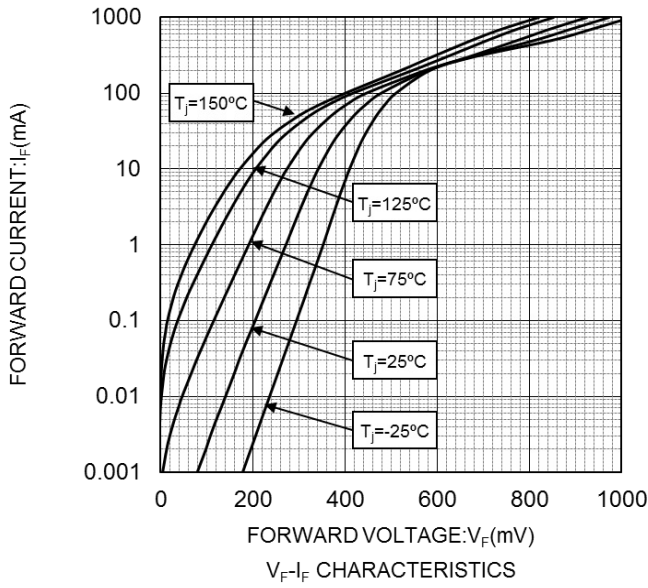
#### ● 内部回路図



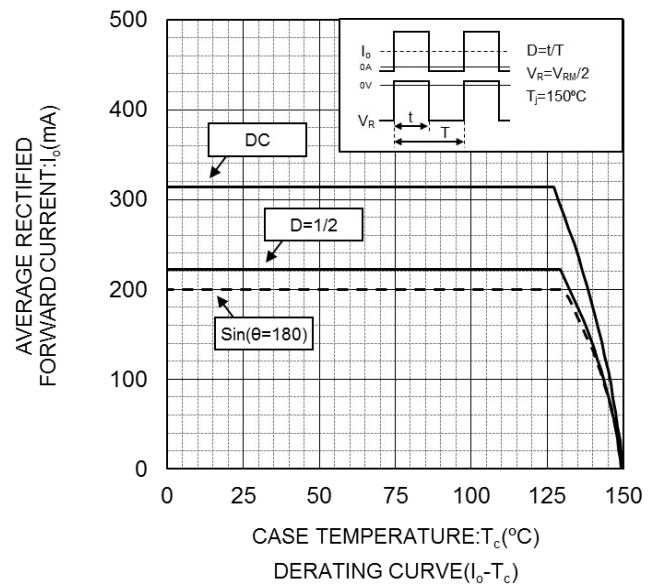
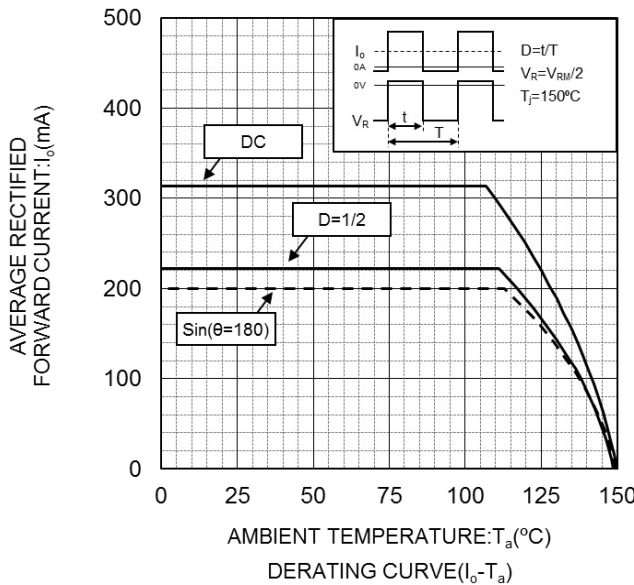
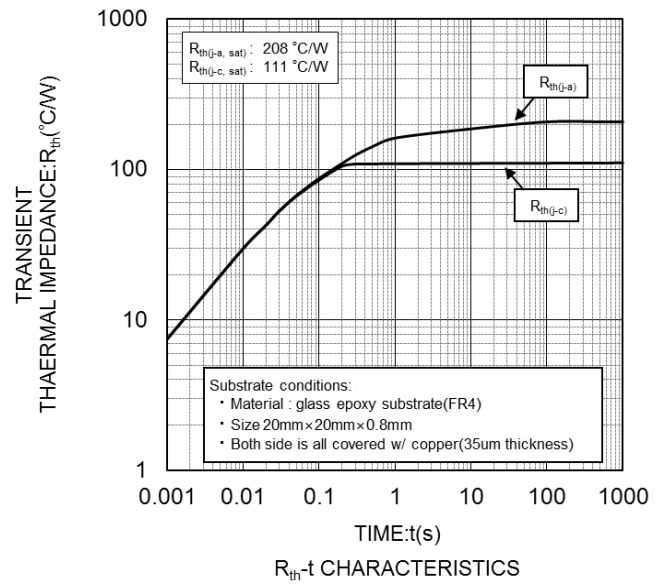
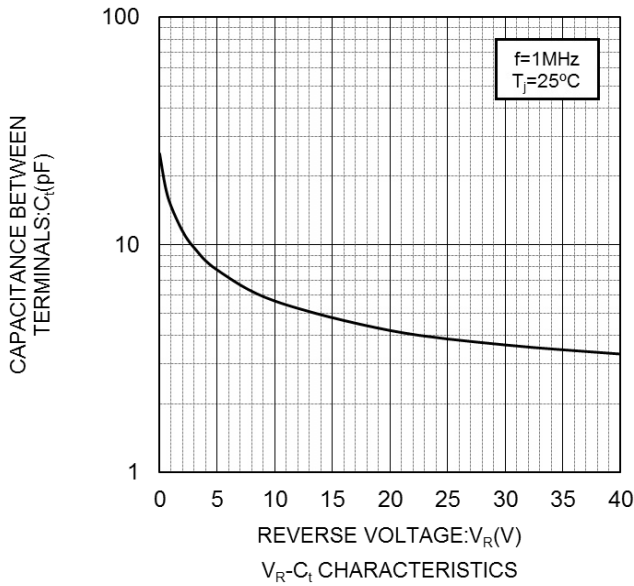

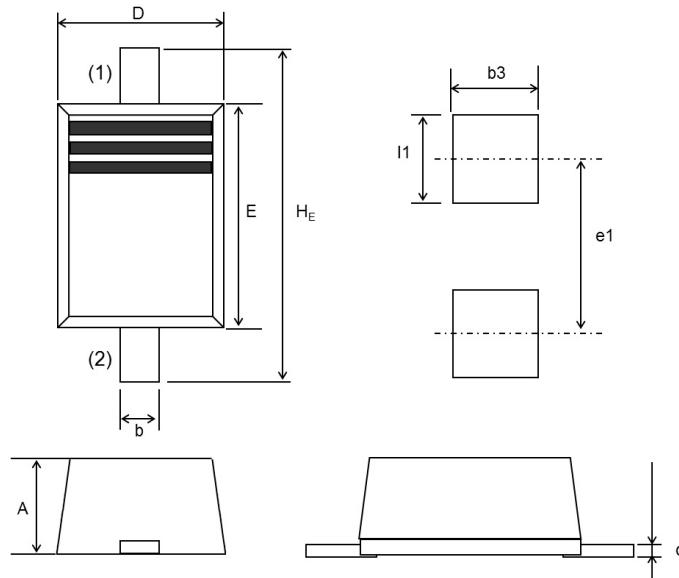
● Characteristic Curves

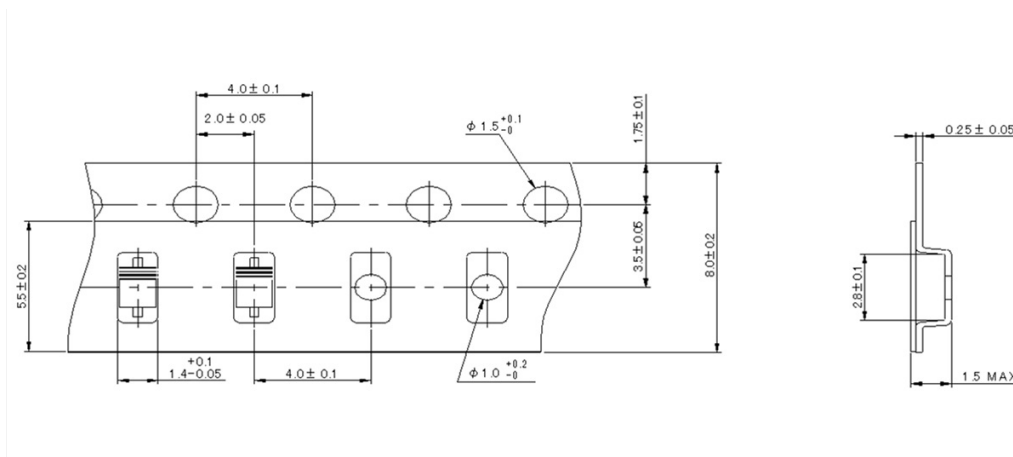
