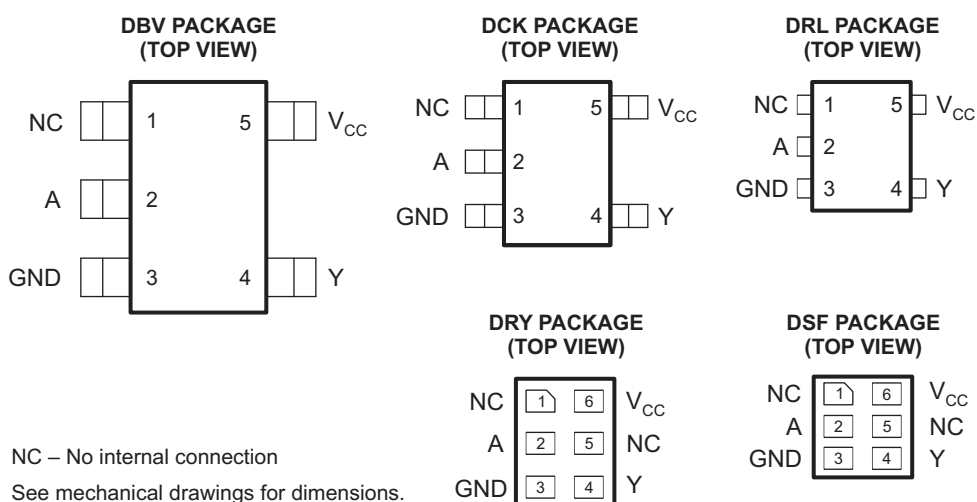

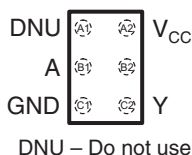

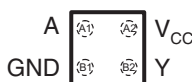

This single inverter gate is designed for 1.65-V to 5.5-V V_{CC} operation.

The SN74LVC1G04 performs the Boolean function $Y = \bar{A}$.

NanoFree™ package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using I_{off} . The I_{off} circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.

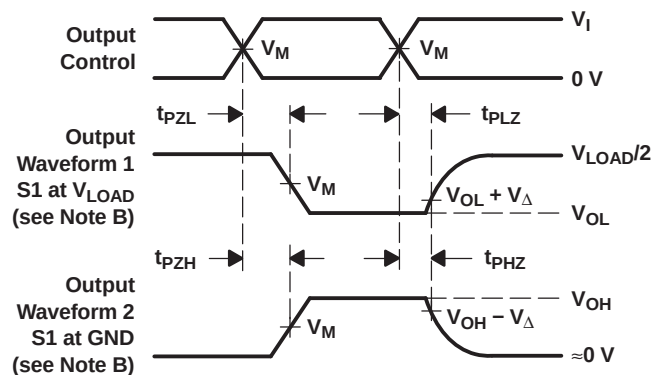
VOLTAGE WAVEFORMS

INVERTING AND NONINVERTING OUTPUTS

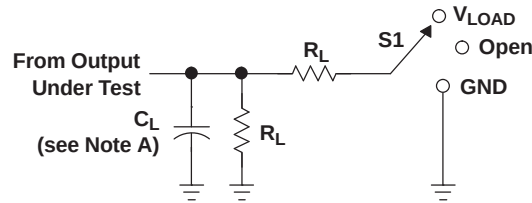

Figure 1. Load Circuit and Voltage Waveforms

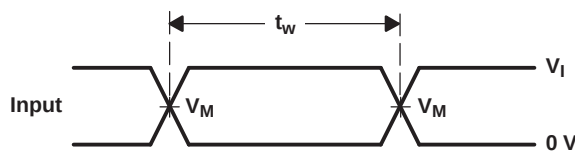
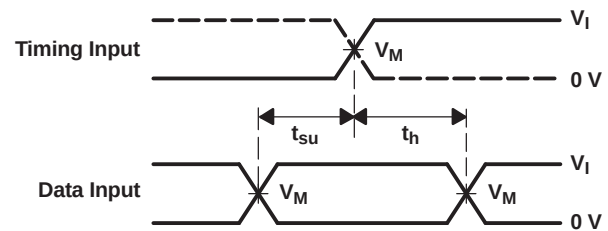
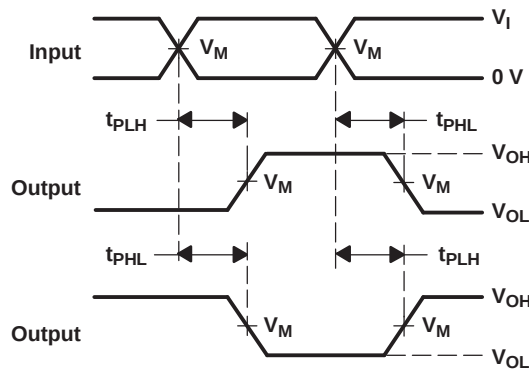
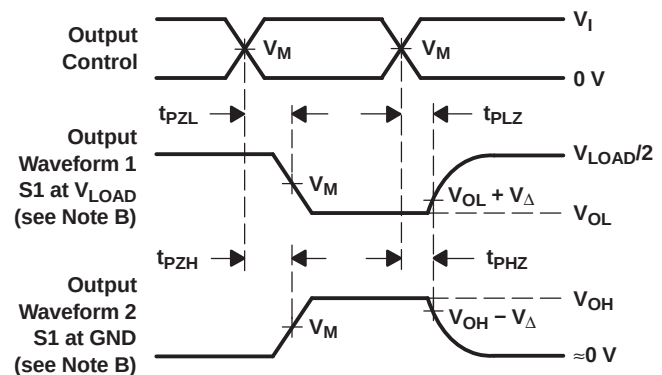

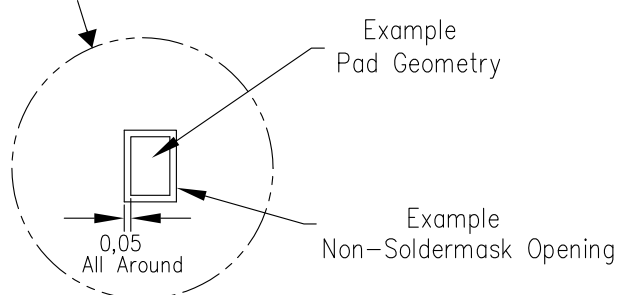
Example Board Layout

Non-Soldermask Defined Pad

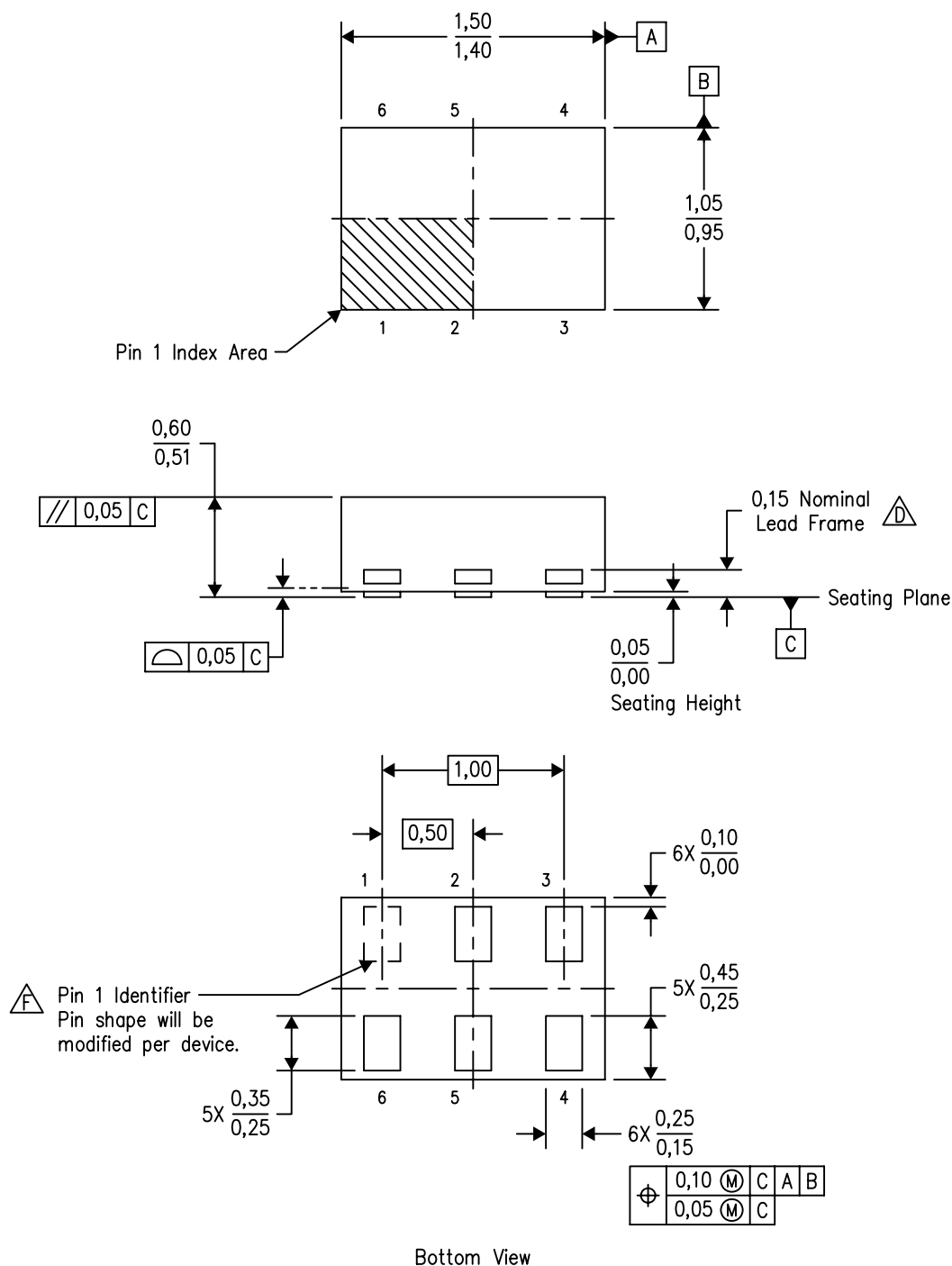
