

#### **DESCRIPTION/ORDERING INFORMATION (CONTINUED)**

The TRS3232E device consists of two line drivers, two line receivers, and a dual charge-pump circuit with  $\pm 15$ -kV IEC ESD protection pin to pin (serial-port connection pins, including GND). The device meets the requirements of TIA/EIA-232-F and provides the electrical interface between an asynchronous communication controller and the serial-port connector. The charge pump and four small external capacitors allow operation from a single 3-V to 5.5-V supply. The devices operate at data signaling rates up to 250 kbit/s and a maximum of 30-V/ $\mu$ s driver output slew rate.








Figure 1. Driver Slew Rate

NOTES: A. C<sub>L</sub> includes probe and jig capacitance.


