

Description

The LH1526 relay is two SPST normally open switches that can replace electromechanical relays in many applications. The relays require a minimal amount of LED drive current to operate, making it ideal for battery powered and power consumption sensitive applications. The relay is constructed using a GaAIAs LED for actuation control and an integrated monolithic die for the switch output. The die is, fabricated in a high-voltage dielectrically isolated technology, comprised of a photodiode array, switch-control circuitry, and MOSFET switches. In addition, the relay employs current-limiting circuitry, enabling it to pass FCC 68.302 and other regulatory surge requirements when overvoltage protection is provided. The relay can be configured for ac/dc or dc-only operation.




Figure 1. Recommended Operating Conditions




Figure 3. LED Current for Switch Turn-on vs. Temperature




Figure 2. LED Voltage vs. Temperature




Figure 4. ON-Resistance vs. Temperature




Figure 5. LED Dropout Voltage vs. Temperature




Figure 8. Switch Capacitance vs. Applied Voltage




Figure 6. Current Limit vs. Temperature




Figure 9. Output Isolation




Figure 7. Variation in ON-Resistance vs. LED Current




Figure 10. Leakage Current vs. Applied Voltage at Elevated Temperatures






Figure 11. Insertion Loss vs. Frequency




Figure 14. Switch Offset Voltage vs. Temperature




Figure 12. Leakage Current vs. Applied Voltage




Figure 15. Turn-on Time vs. Temperature




Figure 13. Switch Breakdown Voltage vs. Temperature




Figure 16. Turn-on Time vs. LED Current




Figure 17. Turn-off Time vs. Temperature





Figure 18. Turn-off Time vs. LED Current


