Typical Impedance Characteristics:



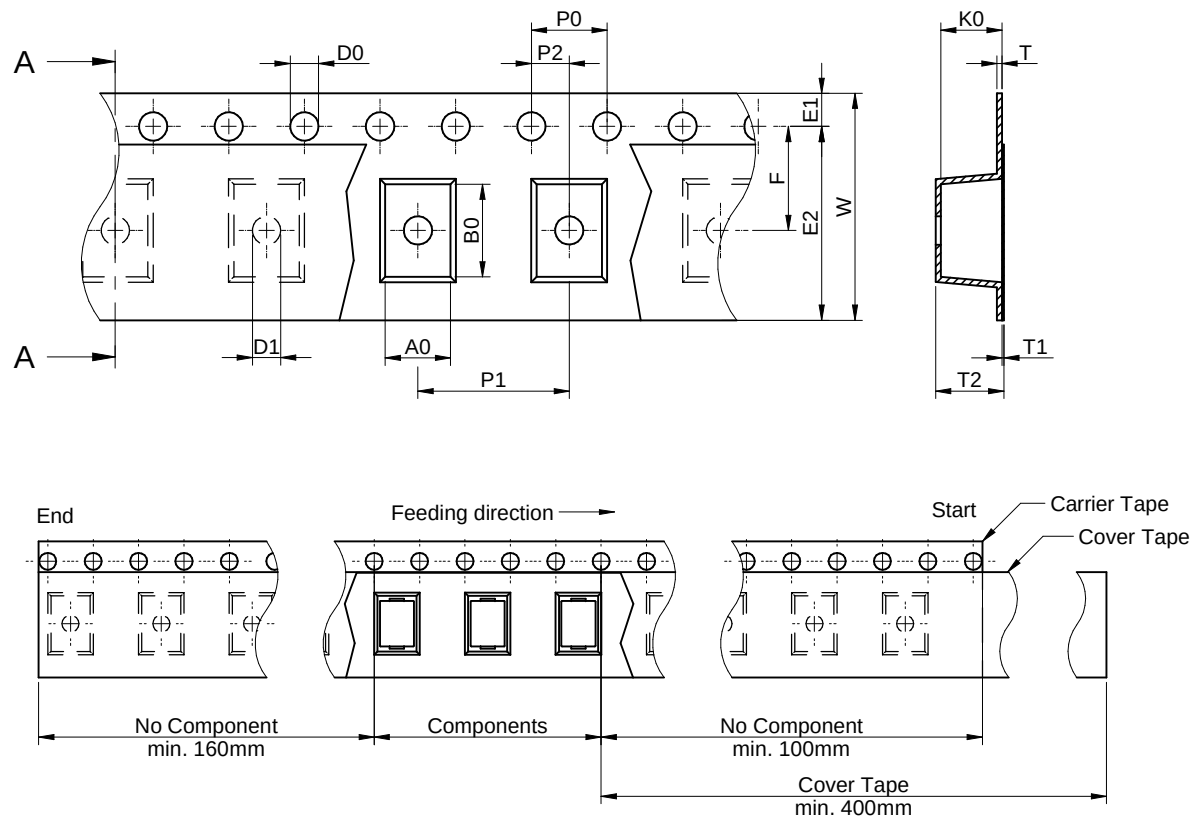
Derating Curve:

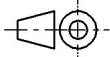
Direct mechanical impact to the product shall be prevented as the ferrite material of the ferrite body could flake or in the worst case it could break.

Product specific:

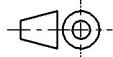
